Regional self-assessment: existing challenges

CHALLENGES RELATED TO THE REGIONAL CONTEXT

HIGH SHARE OF SOCIAL HOUSING UNITS
IN NEED OF GREEN RENOVATIONS

DIVERSITY OF CONSTRUCTIVE
TECHNOLOGIES AND, AS A RESULT, OF
REHABILITATION NEEDS

FUEL POVERTY IS PARTICULARLY
PREVALENT AMONGST SOCIAL HOUSING
RESIDENTS

Unsuitability of energy-active solutions (in face of the energy-related behaviour of residents)

CHALLENGES RELATED TO ENERGY REGULATIONS

NATIONAL REGULATIONS DO NOT
ADDRESS THE RETROFITTING OF SOCIAL
HOUSING IN ITS OWN TERMS

ENERGY CERTIFICATION SYSTEM IS NOT TUNED WITH EXISTING TERRITORIAL SPECIFICITIES

CHALLENGES RELATED TO POLICY INSTRUMENTS

LACK OF COORDINATION BETWEEN
DIFFERENT POLICY INSTRUMENTS (OR
EVEN WITHIN THE SAME INSTRUMENT)

FROM THE PROGRAMMES OF THE EU
COHESION POLICY IN PORTUGAL, ONLY
THE ROP CAN BE USED IN THE REGION

LIMITED ADAPTABILITY OF THE CONDITIONS FOR USING PUBLIC FUNDS TO RETROFIT SOCIAL HOUSING

PROCEDURAL-RELATED CONSTRAINTS IN
THE MANAGEMENT OF INSTRUMENTS
HAMPERS ITS EFFECTIVENESS

LACK OF EVIDENCE ON THE IMPACTS OF GREEN RENOVATIONS SUPPORTED BY PUBLIC FUNDS

LACK OF FOCUS ON THE PROMOTION OF REGIONAL/LOCAL CAPACITY BUILDING ON ENERGY AND RESOURCE EFFICIENCY



Action plan: vision and objectives

Vision Towards an energy efficient social housing sector that contributes to the alleviation of the phenomenon of fuel poverty in Norte

Objectives

- Enhance the energy performance of social housing
- Alleviate the problem of fuel poverty in social housing
- Improve the knowledge base for the design of social housing policies
- Adapt existing policy instruments to the territorial specificities of Norte
- Promote networking and partnerships working



NEEDS ADDRESSED

- POTENTIALLY HIGH NUMBER OF SOCIAL HOUSING UNITS IN NEED OF RENOVATIONS
- DIFFICULTIES IN GETTING ACCESS TO EXISTING FUNDING OPPORTUNITIES (NAMELY BECAUSE OF THE LACK OF COORDINATION BETWEEN THEM)
- LACK OF FUNDING OPPORTUNITIES, NAMELY AT THE REGIONAL LEVEL, FOR PROMOTING GREEN RENOVATIONS IN SOCIAL HOUSING

POLICY IMPROVEMENT

INCREASE THE FINANCIAL ENVELOPE ALLOCATED UNDER ROP NORTE 2020 TO GREEN RENOVATIONS IN SOCIAL HOUSING

INTER-REGIONAL LESSONS





- 1. CARRY OUT A MAPPING OF EXISTING
 RETROFITTING NEEDS IN SOCIAL HOUSING
- 2. DISSEMINATE THE MAPPING RESULTS TO KEY LOCAL PLAYERS
- 3. SUPPORT THE LAUNCH OF A NEW CALL FOR PROPOSALS TO GREEN RENOVATIONS IN SOCIAL HOUSING, AFTER A FORMAL INCREASE OF THE FINANCIAL ALLOCATION OF THE ROP NORTE 2020 FOR THIS PURPOSE
- 4. Monitor the results of the call, and decide on further activities





Enhance the efficiency of project selection procedures for delivering EU support to the green retrofitting of social housing in Norte

NEEDS ADDRESSED

- SIGNIFICANT DELAYS IN THE ASSESSMENT OF PROPOSALS SUBMITTED TO CALLS LAUNCHED, UNDER ROP NORTE 2020, TO SUPPORT GREEN RENOVATIONS IN SOCIAL HOUSING
- PROCEDURAL-RELATED CONSTRAINTS IN THE MANAGEMENT OF ROP NORTE 2020 RESULT IN MISSING OPPORTUNITIES FOR BENEFICIARIES APPLYING FOR EU FINANCIAL SUPPORT

- 1. CARRY OUT AN ASSESSMENT OF THE ADMINISTRATIVE CONSTRAINTS LIMITING THE PROJECT-SELECTION PROCESSES IN THE ROP
- 2. DEVELOP AND DISSEMINATE A PROPOSAL TO STREAMLINE THE PROJECT-SELECTION PROCESSES IN THE ROP
- 3. TEST AND IMPLEMENTATION OF THE PROPOSAL PRODUCED IN THE PREVIOUS ACTIVITY
- 4. MONITOR THE IMPACT OF THE IMPROVEMENTS
 ON THE ADMINISTRATIVE CONSTRAINTS AND
 DECIDE ON FURTHER ACTIVITIES





Improve monitoring and evaluation tools of public policies focused on the green retrofitting of social housing in Norte

NEEDS ADDRESSED

- LACK OF DATA, AT BOTH REGIONAL AND LOCAL LEVELS, ON THE ENERGY PERFORMANCE OF SOCIAL HOUSING UNITS
- LACK OF EVIDENCE ON THE REAL IMPACTS OF GREEN RENOVATIONS IN SOCIAL HOUSING
- ENERGY CERTIFICATION SYSTEM IN PORTUGAL IS NOT TUNED WITH EXISTING TERRITORIAL SPECIFICITIES

DESIGN, TEST AND DISSEMINATE TOOLS TO CREATE EVIDENCE ON THE IMPACTS OF THE ROP SUPPORT TO THE GREENING OF SOCIAL HOUSING

- 1. CARRY OUT A TERRITORIAL ANALYSIS ON THE DYNAMICS OF THE ROP SUPPORT TO THE GREENING OF SOCIAL HOUSING
- 2. DESIGN AND TEST MEASUREMENTS OF REAL ENERGY SAVINGS IN A SELECTION OF SOCIAL HOUSING UNITS SUPPORTED BY THE ROP
- 3. DEVELOP AND DISSEMINATE A TECHNICAL REFERENCE ON ASSESSING THE IMPACT OF ENERGY EFFICIENT ACTIONS IN SOCIAL HOUSING
- 4. SUPPORT THE INCLUSION OF NEW INDICATORS IN MONITORING SYSTEM OF THE ROP





Improve the energy-related behavior of the social housing residents in Norte Region, particularly after EU supported green renovations

NEEDS ADDRESSED

- ENERGY EFFICIENT TECHNOLOGIES MIGHT NOT TRANSLATE INTO IMPROVED ENERGY PERFORMANCE IN SOCIAL HOUSING
- ENERGY CONSUMPTION PATTERNS OF SOCIAL HOUSING RESIDENTS ARE QUITE SPECIFIC
- PUBLIC POLICIES OFTEN OVERLOOK THE BEHAVIORAL DIMENSION OF ENERGY EFFICIENCY IN SOCIAL HOUSING CONTEXTS

POLICY IMPROVEMENT

PROMOTE CHANGES IN THE ENERGY-RELATED BEHAVIOR OF SOCIAL HOUSING RESIDENTS IN A TARGETED MANNER

IMPACT DIRECT

- 1. DESIGN AND ADMINISTER A SURVEY ON THE ENERGY-RELATED BEHAVIOR OF SOCIAL HOUSING RESIDENTS
- 2. ISSUE A POLICY PAPER ON IMPROVING THE ENERGY-RELATED BEHAVIOR, SUPPORTED BY THE SURVEY RESULTS
- 3. DESIGN AND TEST INITIATIVES TO PROMOTE CHANGES IN THE ENERGY-RELATED BEHAVIOR OF SOCIAL HOUSING RESIDENTS
- 4. EVALUATE THE RESULTS OF THE TESTED INITIATIVES AND DECIDE ON FURTHER ACTIVITIES
